Dear Friends of Church Island and Bay Lake Camp,

As treasured friends and neighbors of Church Island, we want to let you know about changes to the ownership and operating structure of Bay Lake Camp and invite you to meet with us to consider what the future might bring.

Despite great effort and much attention to Bay Lake Camp and the financial challenges associated with the “great recession,” First Lutheran Church finds that it can no longer operate Bay Lake Camp by itself. In 2008, the recession deepened just as we completed large scale fundraising and rebuilding efforts on Church Island, while at the same time, limiting future development by placing Church Island in a conservation easement with the Minnesota Department of Natural Resources. This conservation easement will remain in effect forever. While we have experienced continued growth into a new business plan since that time, it has not developed as quickly as we had hoped. We are eager to explore ways in which we all can continue to enjoy, thrive, and grow through the camp experience on the Island and it’s many community based events throughout the year. Whether through life-changing leadership camps, weddings/family gatherings or spiritual pilgrimage, the journey to the island and back again, is one which produces memories for a lifetime. Each of us has a unique investment through our shared memories and our hopes for a thriving future for people of all ages and all walks of life.

With the future in mind, First Lutheran Church will be listing Church Island with Debra Flam and her team at Edina Realty with our priority being a sale to a non-profit entity or group of people with a like-minded mission, with whom we can partner. We look to you, our friends and supporters, for your ideas and suggestions to help build Church Island’s next chapter.
